Terms and Conditions

This section must be read and signed by both the player and if under 18 the players legal guardian as well.

I hereby agree that any accident occurring as a result of activities provided by the BTC Football Club will not lead to any blame or cause being accepted nor brought against either the BTC Football Club, Nor any of its members/officers whom cannot be held responsible. I also agree that in the event of any accident or emergency, medical advice may be sought and first aid administered.

I agree that either I / my child may have their photograph taken for the use of club publicity and that it may be taken by club officials.

I agree to me or my Childs details being stored by BTC Football Club in accordance with the Data Protection Act.

I agree that I have read and understood the codes of conduct in relation to both me or my child's activities on and off the pitch, as well as the codes of conduct for parents / Supporters. (If applicable)

I agree to abide to the clubs terms and conditions as set by the BTC Football Clubs management committee and accept that in such event either I or my child's actions bring the club into disrepute; my child may be de-registered from the BTC Sports and Social Club and all known subsidiaries. In the event of de-registration no monies paid will be refundable

I understand that on my registration being accepted I will be issued with a BTC Membership card that will grant me access to the clubs facilities. I understand that this may be asked for by any club official at any time, if this is not presented, I or we may be asked to leave the club or refused access to any facilities.

I agree that until such time all paperwork and monies have been received, me or my child will not be registered against BTC (Southampton) Football Club and therefore will not be eligible to participate in any activity arranged by the club.

I agree that as a member of BTC Southampton Football club, I will automatically apply for membership to BTC Sports club; this will however be subject to the clubs discession.

Payment and Fines

I understand that BTC Football Club will charge the team £72 per game and this will be divided by the players as deemed by the relevant manager/coach.

I also knowingly agree to pay the £15 registration fee in advance. I understand that if I fail to make the payments before or after every match I play, I will not be allowed to play any further matches until funds have been given and brought back up to date. I understand that if I should knowingly play any further matches after not paying, I may be subject to any action as deemed reasonable by the BTC management committee including such action as de-registration (in this event all monies paid thus far are non returnable)

In the event of any fine, I accept full responsibility for my actions and agree to pay such monies back to the club. BTC Football Club will pay said fines to the required governing body so as to ensure the timely payment but I agree that I will be required to pay this back to the club within 7 days of it being requested. In the event of the Club appealing against any decision made against me I agree that this will not be charged against me and only the original amount will be requested from me. This does not apply if I request it appealed against the advice of the clubs committee and as such any incurring costs must be paid in advance. I agree that if I fail to pay the required amount within the time frame as stipulated on the sent correspondence (7days) I will be subject to a further £5 administration fee. If I still fail to make payment within another 7 days I will be summoned to a disciplinary hearing and will be subject to any disciplinary action, including but not limited to suspension and or deregistration.

Codes of conduct Players

A player should:

1. Make every effort to develop their own sporting abilities, in terms of skill, technique, tactics and stamina.
2. Give maximum effort and strive for the best possible performance during a game, even if his team is in a position where the desired result has already been achieved.
3. Set a positive example for others, particularly young players and supporters.
4. Avoid all forms of gamesmanship, and time wasting.
5. Always have regard to the best interests of the game, including where publicly expressing an opinion on the game and any particular aspect of it, including others involved in the game.
6. Not use inappropriate language.

Obligations towards own team:

A player should:

1. Make every effort consistent with Fair Play and the Laws of the Game to help his own team win.
2. Resist any influence, which might, or might be seen to, bring into question his commitment to the team winning.

Respect for the Laws of the Game and competition rules:

A player should:

1. Know and abide by the Laws, rules and spirit of the game, and the competition rules
2. Accept success and failure, victory and defeat, equally.
3. Resist any temptation to take banned substances or use banned techniques.

Respect towards Opponents: _

A player should:

1. Treat opponents with due respect at all times, irrespective of the result of the game.
2. Safeguard the physical fitness of opponents, avoid violence and help injured opponents.

Respect towards the Match Officials: _

A player should:

1. Accept the decision of the Match Official without protest.
2. Avoid words or actions, which may mislead a Match Official.
3. Show due respect towards Match Officials.

Respect towards Team Officials: _

A player should:

1. Abide by the instructions of their Coach and Team Officials provided they do not contradict the spirit of this Code.
2. Show due respect towards the Team Officials of the opposition.

Obligations towards the Supporters: _

A player should:

1. Show due respect to the interests of supporters.

Codes of conduct Parents / Legal guardians and supporters

Parents / spectators should:

1. Always be positive and encouraging towards all of the children not just their own.
2. Applaud the opposition as well as the own team.
3. Avoid coaching the child during the game.
4. Not to shout and scream.
5. Respect the referee's decision.
6. Give attention to each of the children involved in football not just the most talented.
7. Give encouragement to everyone to participate in football.
8. Agree and adhere to the club's Code of Conduct and Child Protection Policy.
